The final level of ESSA's "promising" evidence provides flexibility to allow schools and districts to test new programs which may add to the knowledge of what works.

The AMSCO® AP U.S. History book is correlated to the 2019 AP Course and Exam Description which is grounded in the learning objectives, key concepts, and historical developments that address the breadth, depth, and complexity of the AP U.S. History exam. The theory of action is based on the AP Course and Exam Description outline and pacing guide. The authors' goal is to provide U.S. history students with the essential content and instructional materials to develop the knowledge, the mastery of historical thinking skills and reasoning processes, and the writing skills needed to understand U.S. history and to approach the past as historians do.
